### **Invitation for Bids for the***Maintenance of Nepal Drugs Limited (North East Wing)*

1. The Government of Nepal [GoN] has allocated funds towards the cost of *Maintenance of Nepal Drugs Limited (North East Wing)* and intends to apply part of the funds to cover eligible payments under the Contract for *NCB/Irrigation/02/2073/74*. Bidding is open to all eligible Nepalese Bidders. The Estimated Amount for the Works is NRs 79,98,883.67 (Without Contingencies).
2. **Department of Local Infrastructure Development and Agricultural Roads, Small Irrigation , River Training and Other Infrastructures Development Section** invites sealed bids or electronic bids from eligible bidders for the construction of *Maintenance of Nepal Drugs Limited (North East Wing)* under National Competitive Bidding procedures. Only eligible bidders with the following key eligibility criteria should participate in this bidding:-
  - (a) Firm, organization or company registration certificate, (b) Business registration license, Explanation (c) Value added tax registration certificate and permanent accounts registration number (PAN) certificate, (d) Tax clearance (e) Declaration made in writing by the bidder that it is not disqualified for taking part in the procurement proceedings, that it has no conflict of interests in the proposed procurement proceedings and that it has not been punished for an offense relating to the concerned profession or business, (f) Such other documents as the public entity considers necessary.
3. A complete set of Bidding Documents may be purchased from the office **Department of Local Infrastructure Development and Agricultural Roads, Small Irrigation, River Training and Other Infrastructures Development Section ,Shreemahal, Lalitpur** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs 3,000.00 till 2073/12/9.If so requested, the Bidding Documents can also be sent by post/courier services.However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from

Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall be held at *Department of Local Infrastructure Development and Agricultural Roads, Small Irrigation, River Training and Other Infrastructures Development Section*, at 14.00 hrs. on 2073/11/30.
6. Sealed or electronic bids must be submitted to the office *Department of Local Infrastructure Development and Agricultural Roads, Small Irrigation, River Training and Other Infrastructures Development Section* by hand/courier or through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np) on or before 12.00 hrs noon on 2073/12/10. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14.00 hrs on 2073/12/10 at the office of *Department of Local Infrastructure Development and Agricultural Roads, Small Irrigation, River Training and Other Infrastructures Development Section*. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs **200000.00** which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
