1. Local Bridge Section/ DoLI has received budget from Government of Nepal for Procurement of Bulldoggrips (Cable clamps). LBS/ DoLI intends to apply part of the funds to cover eligible payments under the Contract for Procurement. "Bulldoggrips (Cable clamps), ICB/TB/BG/2-2020/21"Bidding is open to all eligible Bidders from all countries.

2. Department of Local Infrastructure (DoLI) invites electronic bids from eligible bidders for the procurement of *Bulldoggrips (Cable clamps) under International competitive bidding procedures specified in Public Procurement Act and Regulations.*

3. For individual bidder, the bidder must be the manufacturer of Buldoggrips. In case of JV, Lead partner must be manufacturer of Buldoggrips and other partners must be either manufacturer of Buldoggrips or Trail Bridge Steel parts.

4. Eligible Bidders may obtain further information and inspect the bidding documents at the office of DoLI, Shreemahal, Pulchowk or may visit PPMO egp system www.bolpatra.gov.np/egp.

5. Bidder should submit their bid electronically. Bidders may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document as mentioned in the table below in the following Rajaswa (revenue) account as specified below .

6. Pre-bid meeting shall be held on 13 Chaitra 2077 (March 26, 2021) at DoLI, Shreemahal, Pulchowk at 12:00 noon.

7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 noon on 2 Baisakh 2078 (April 15, 2021). Bids received after this deadline will be rejected.

8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM, 2 Baisakh 2078 (April 15, 2021) at the office of DoLI. Bids must be valid for the period mentioned in the table below.

9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
